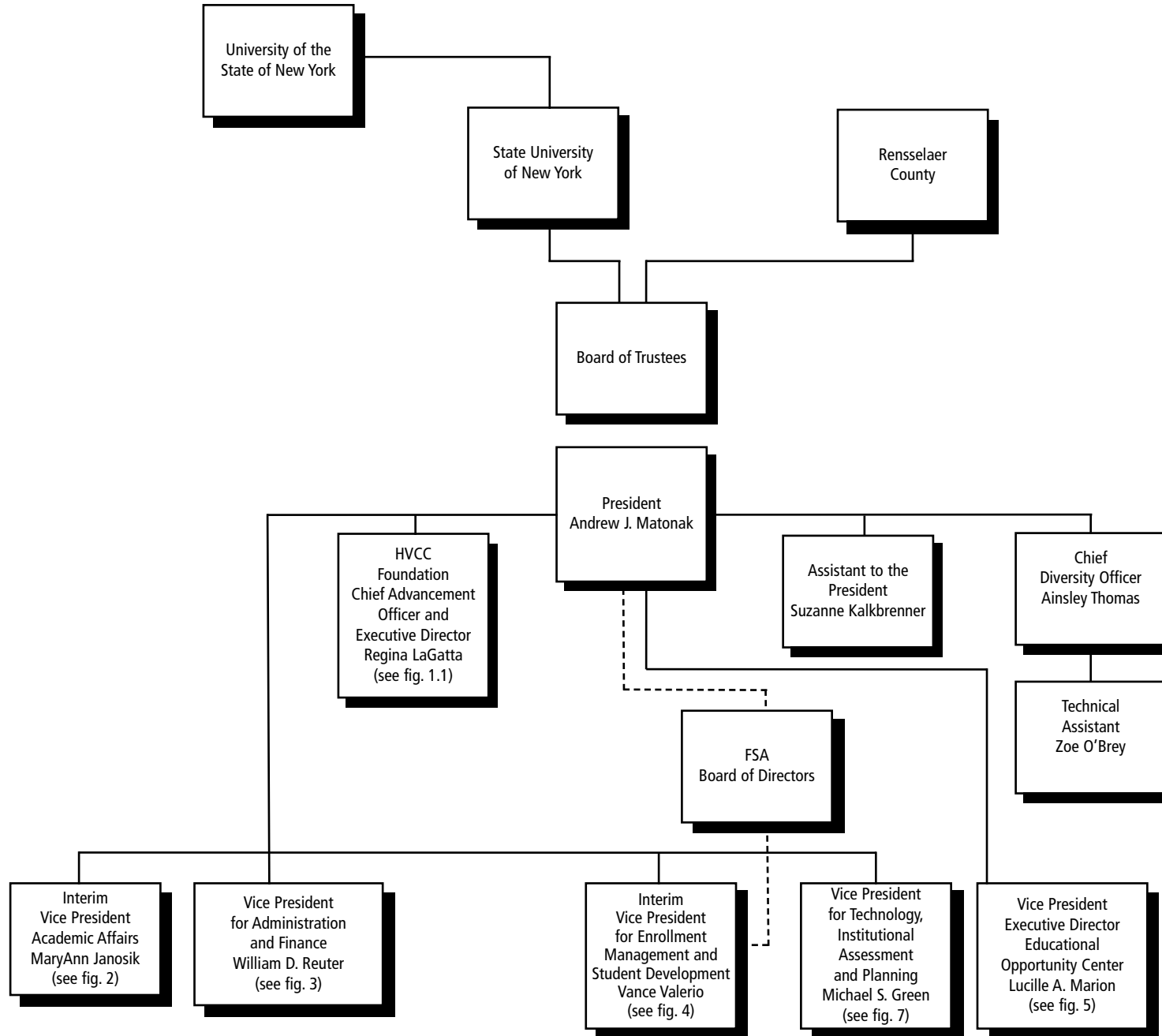

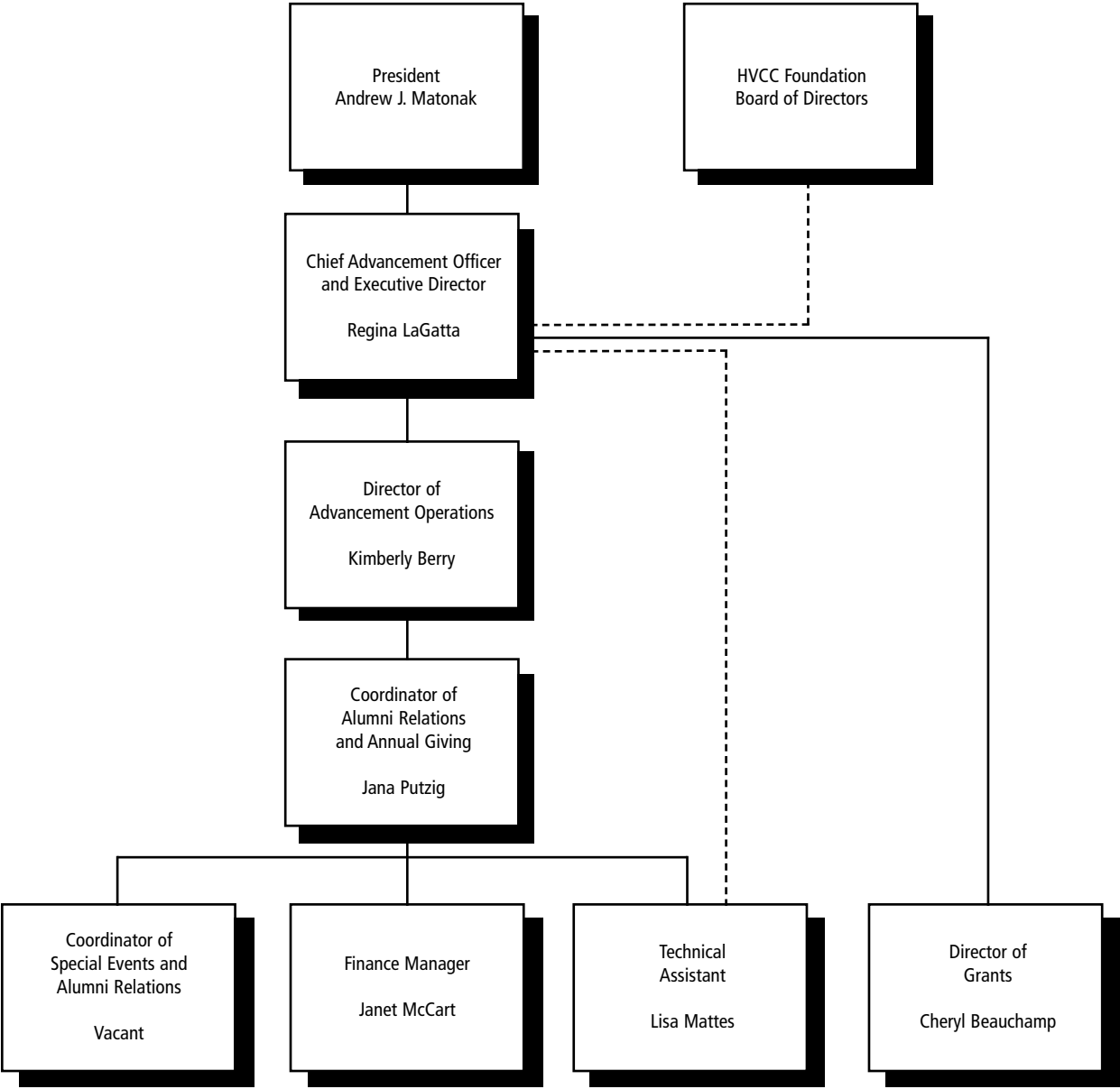

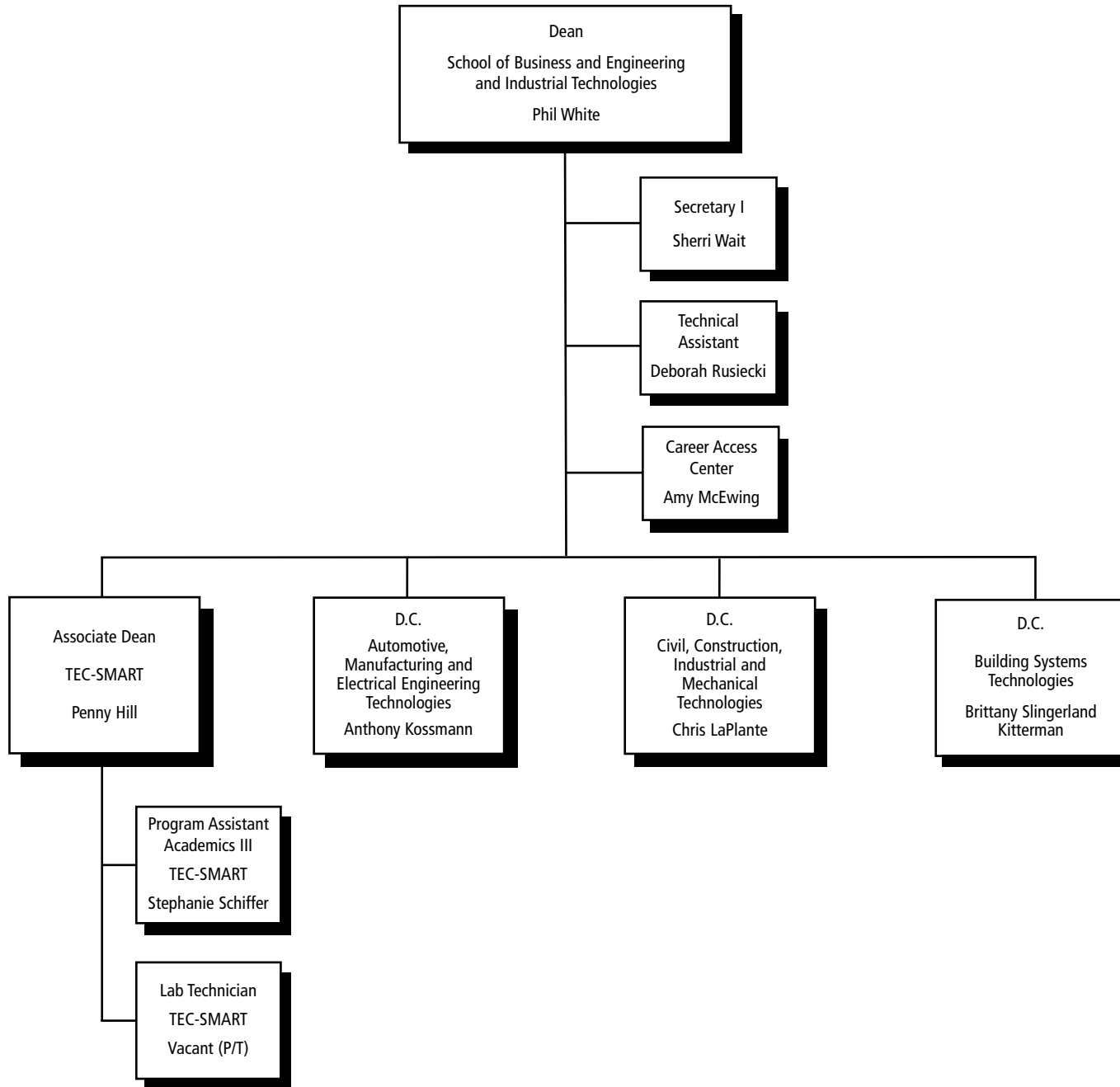

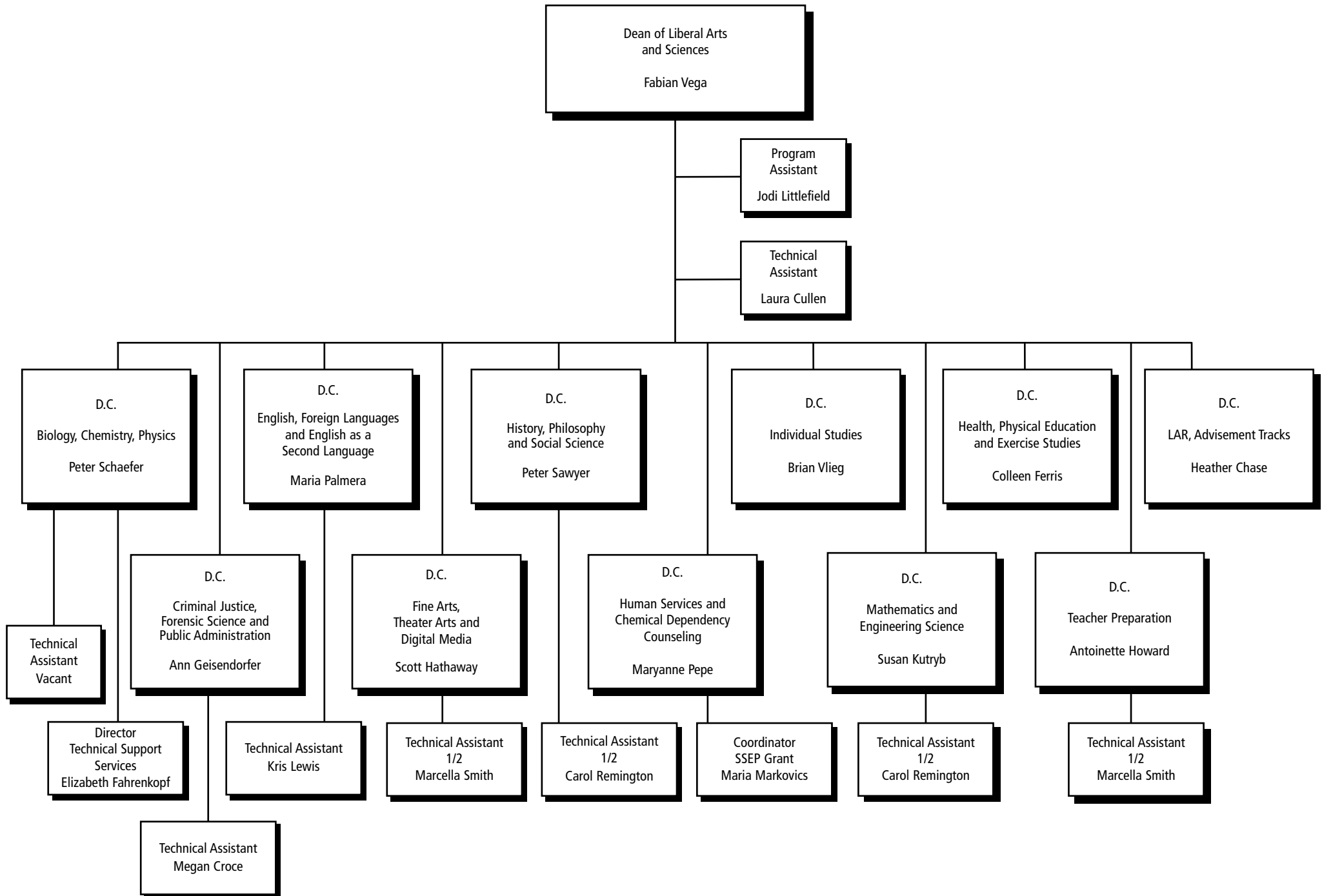

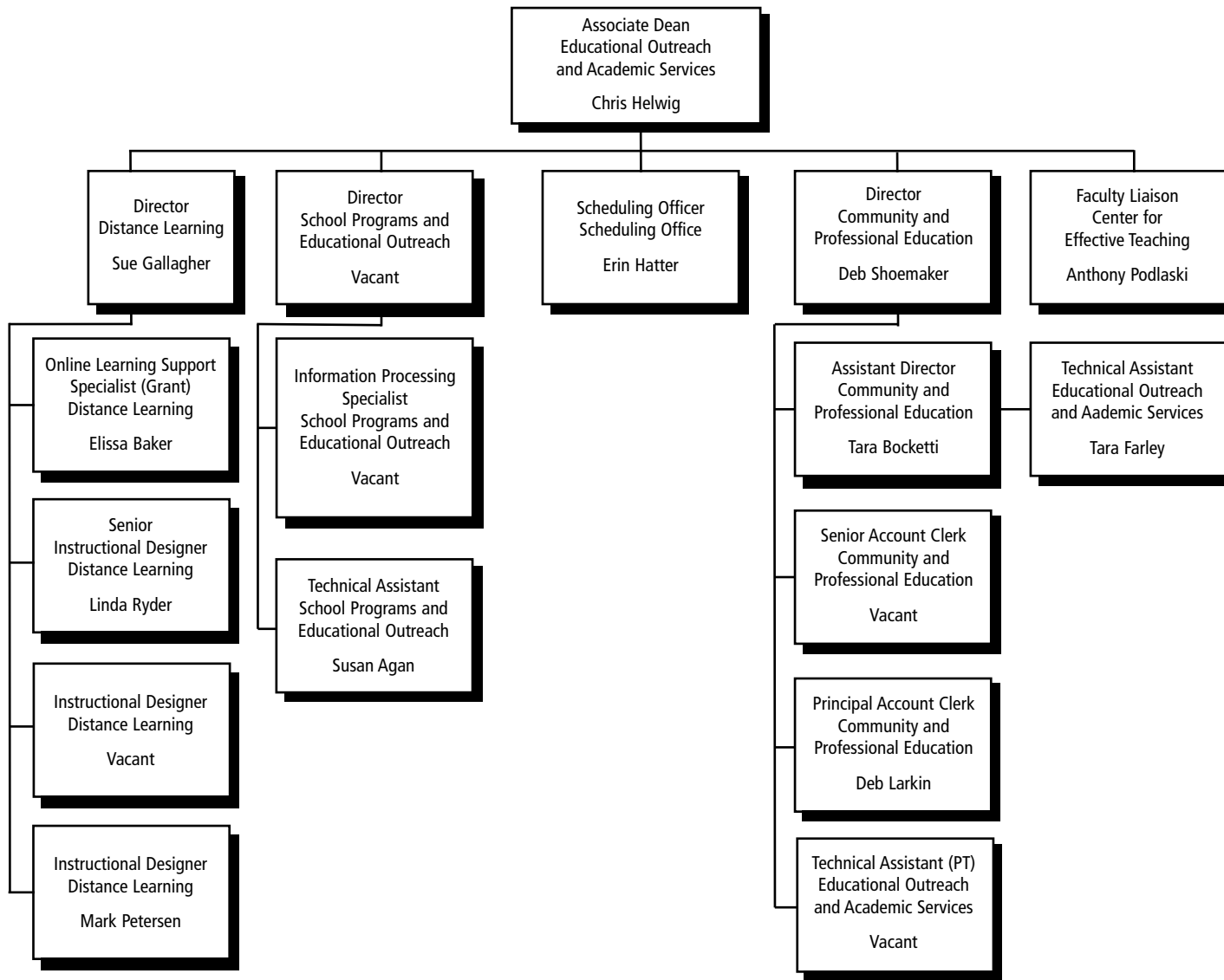

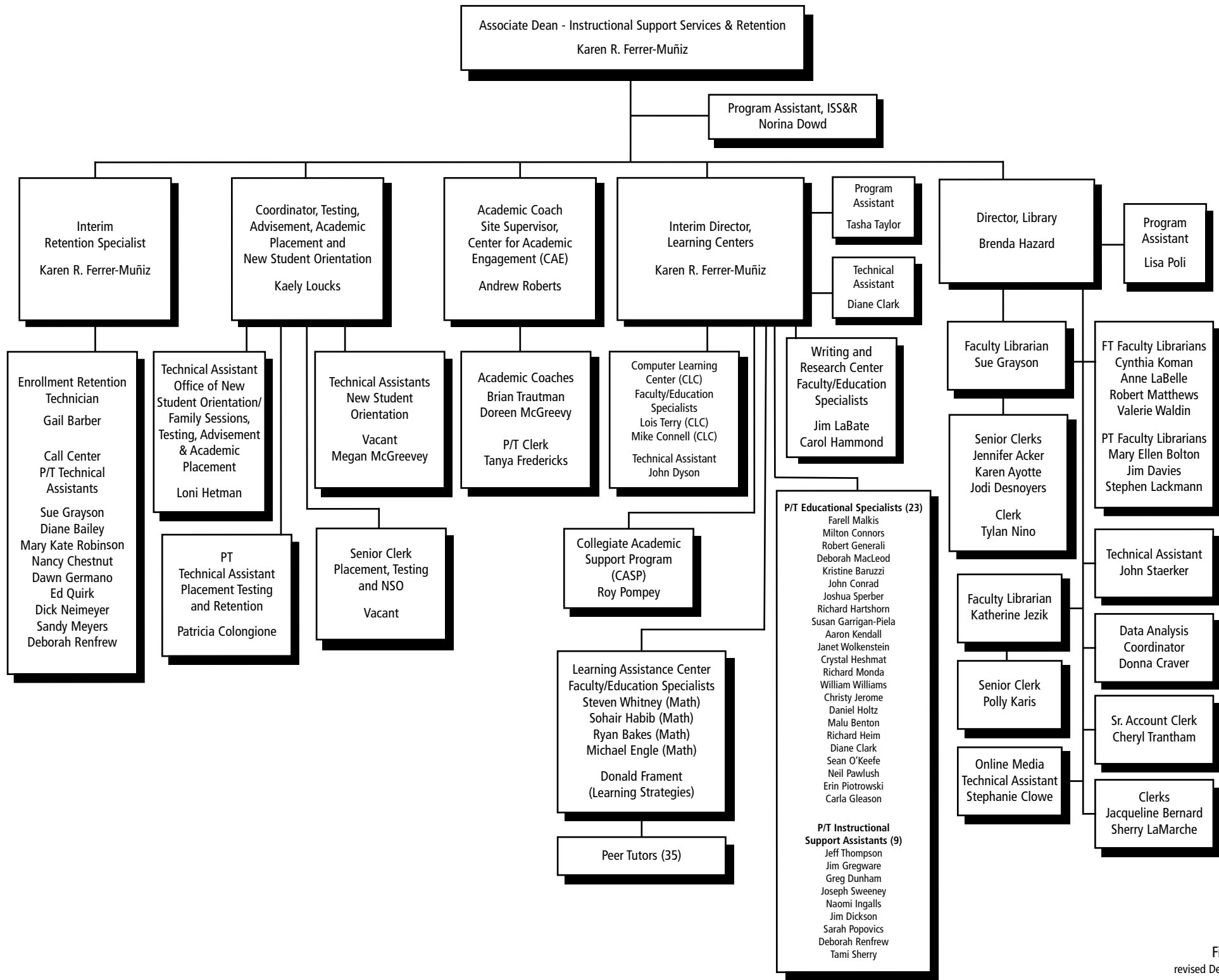

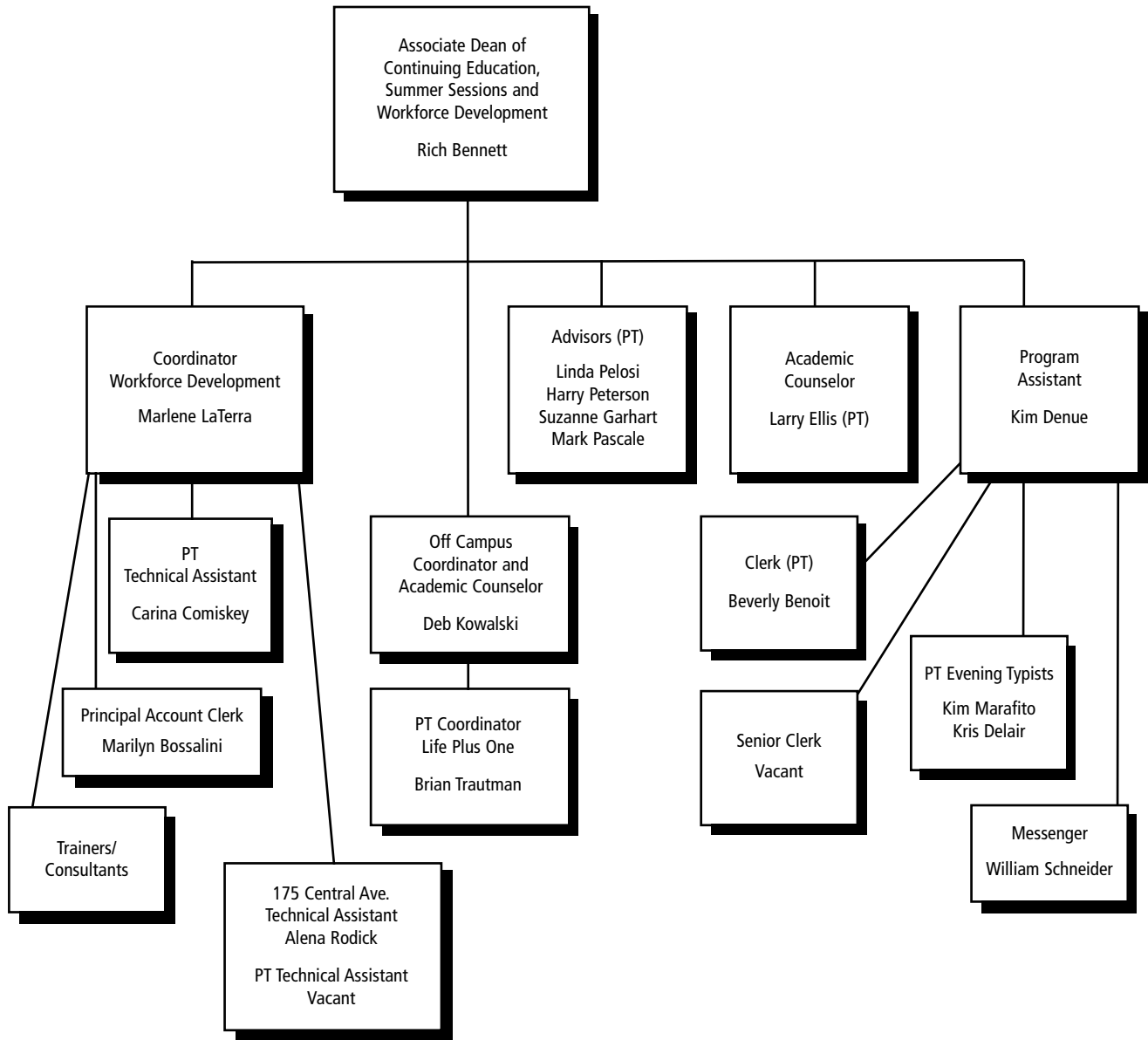

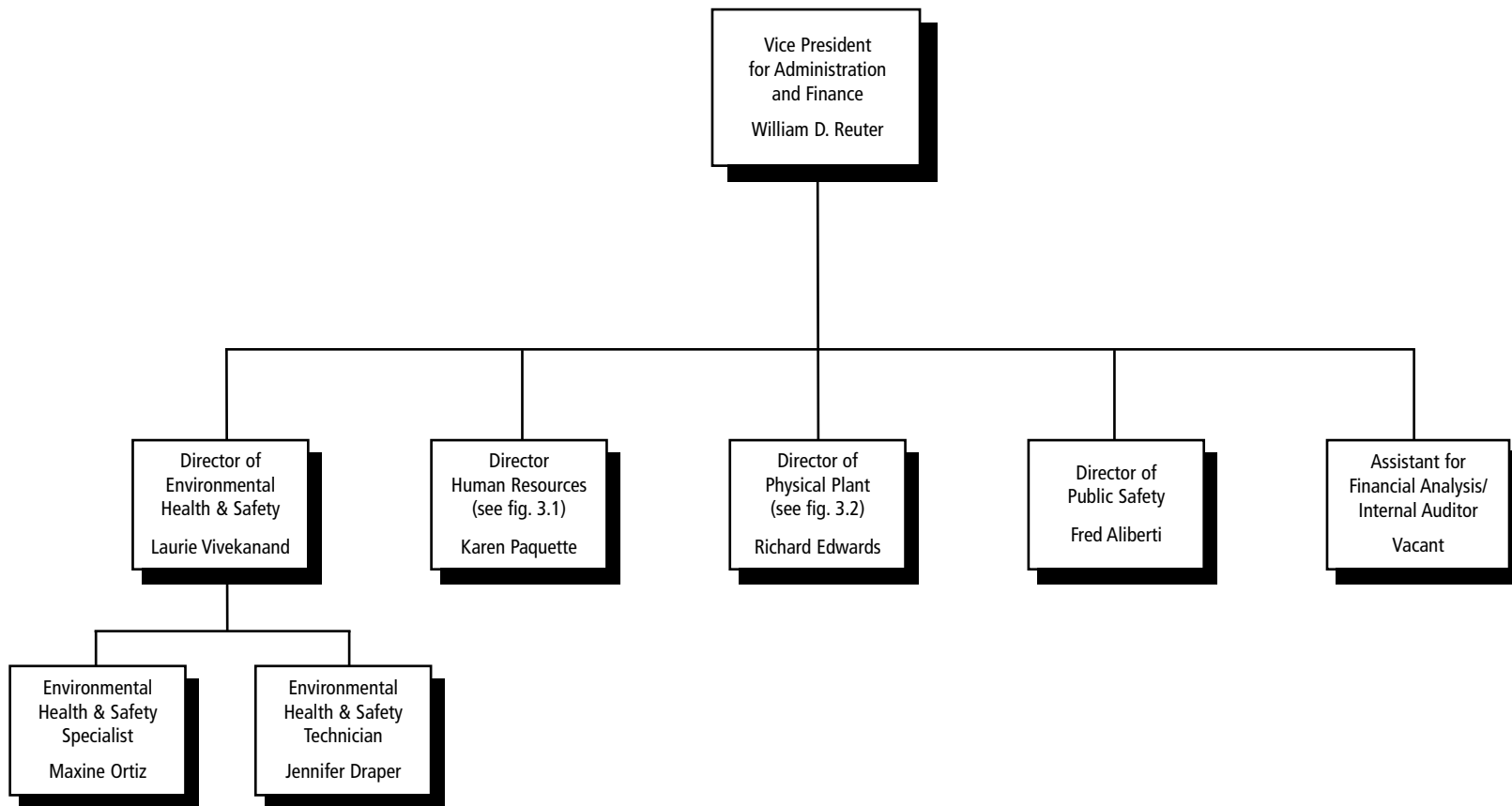

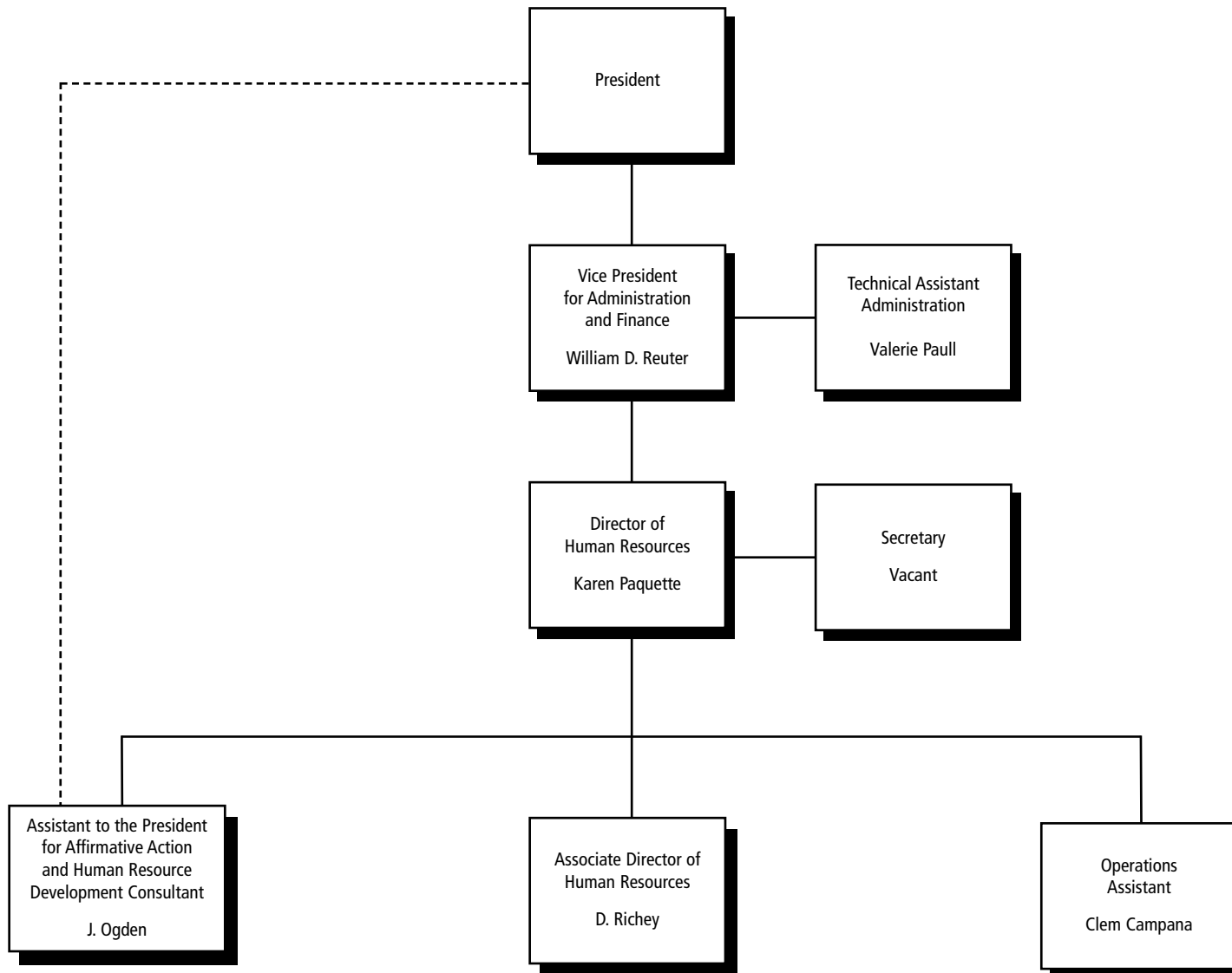

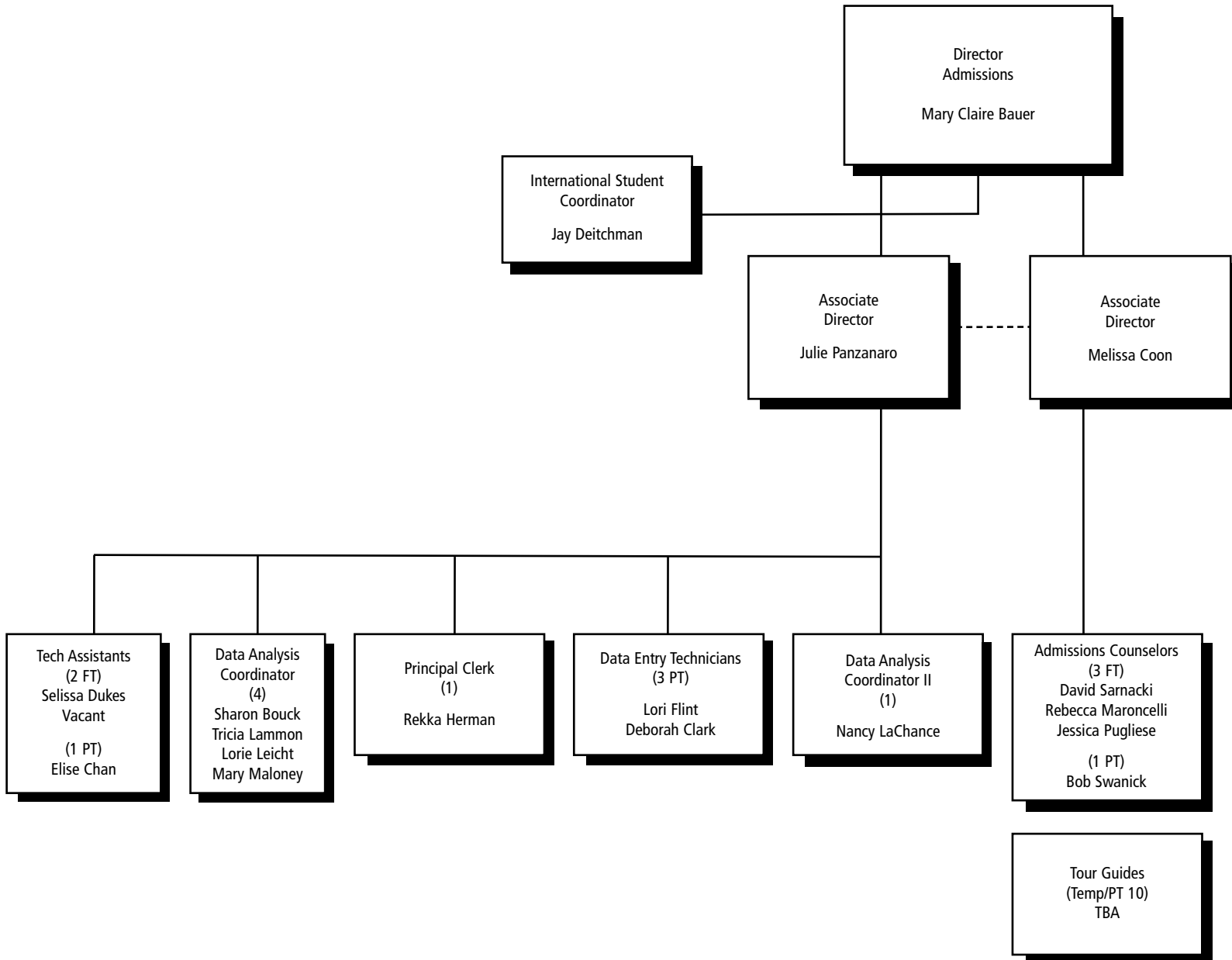

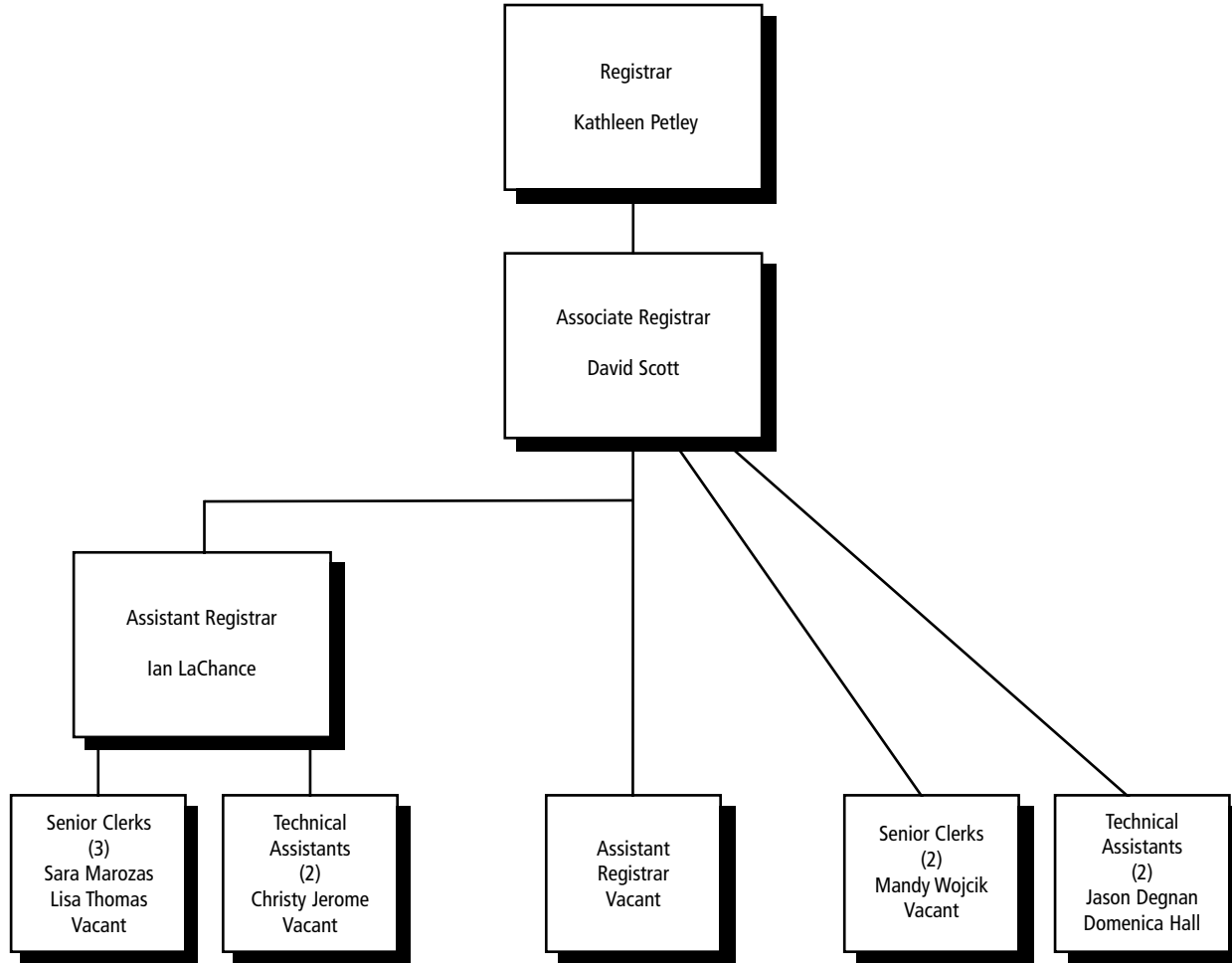

revised Sept. 2017

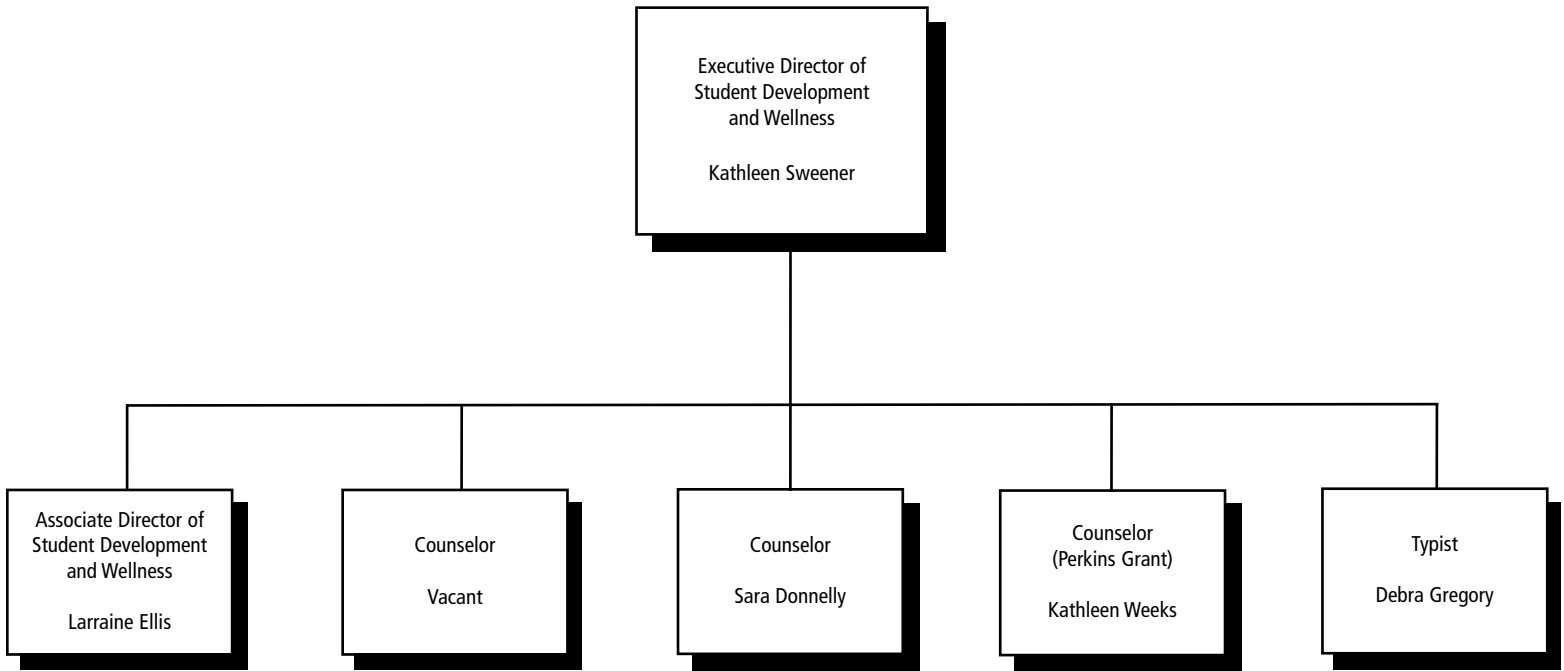

revised Sept. 2017

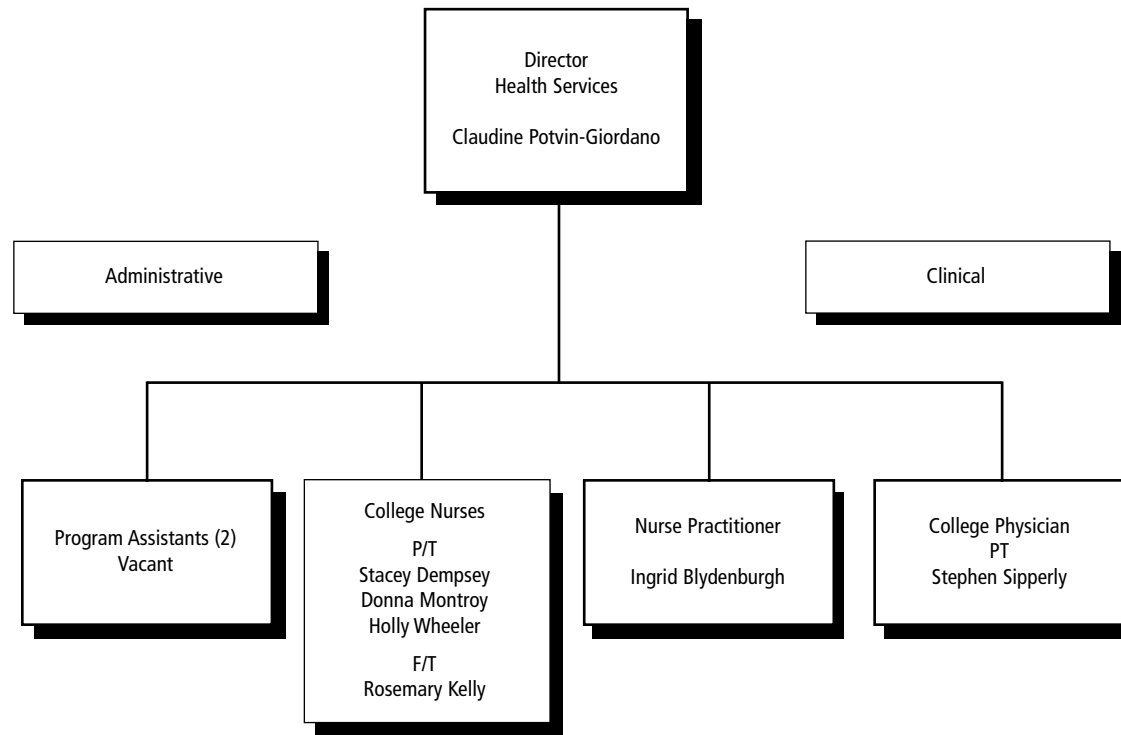

revised Nov. 2017

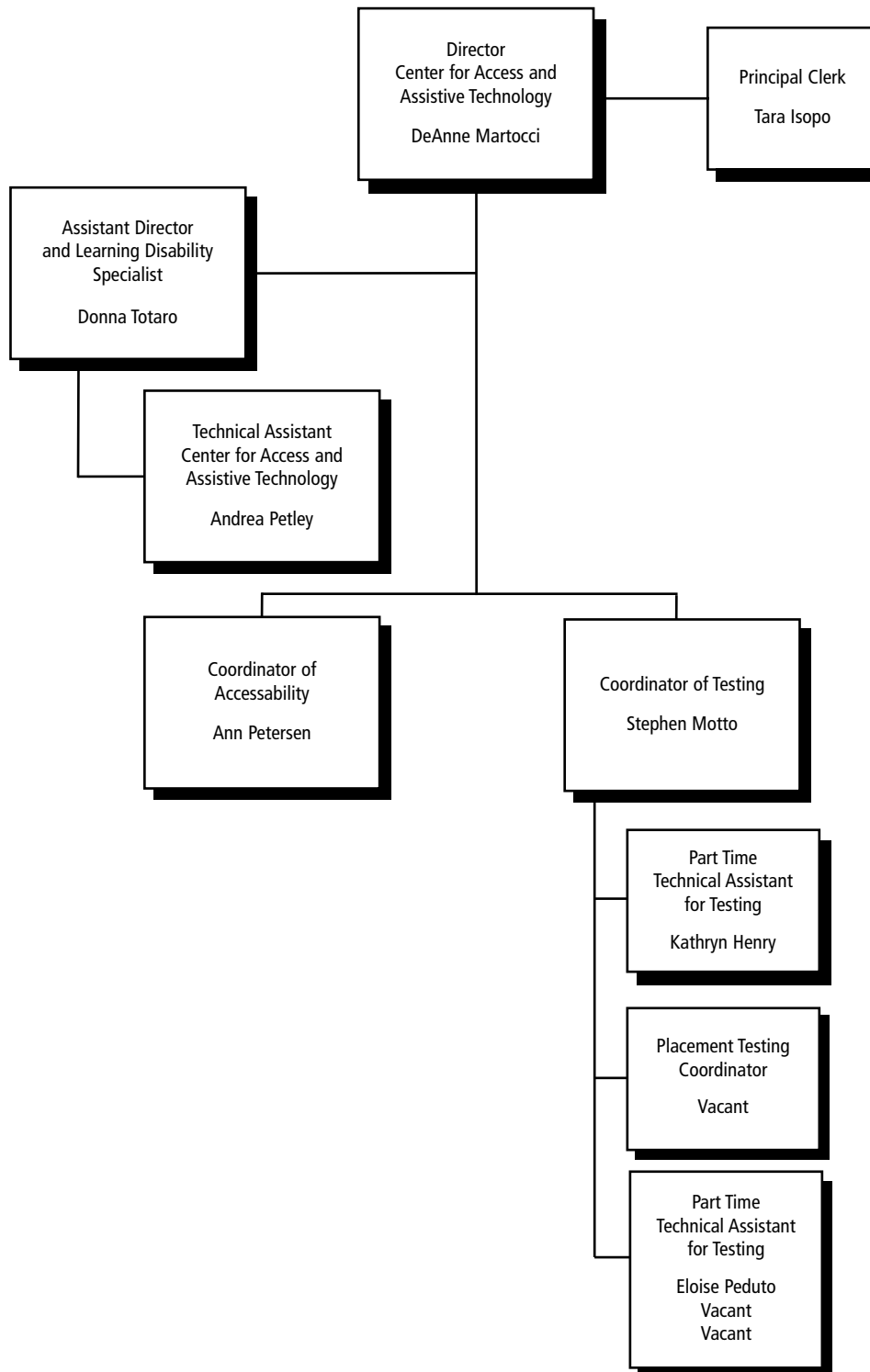

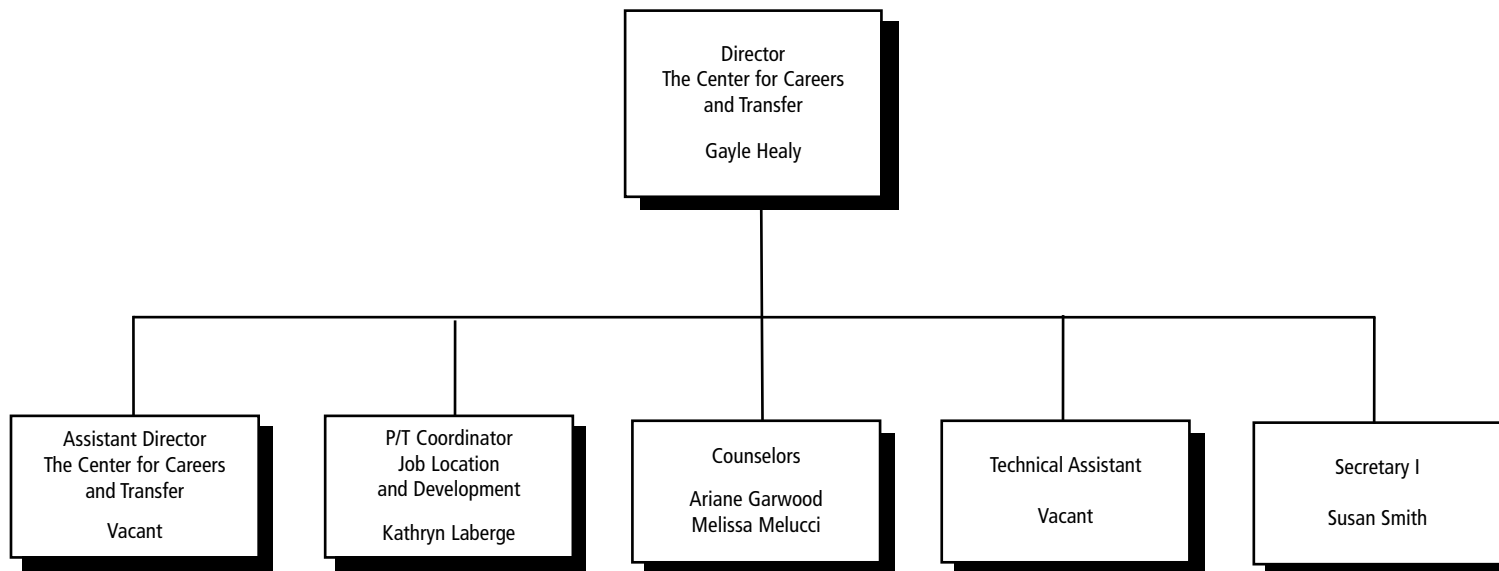

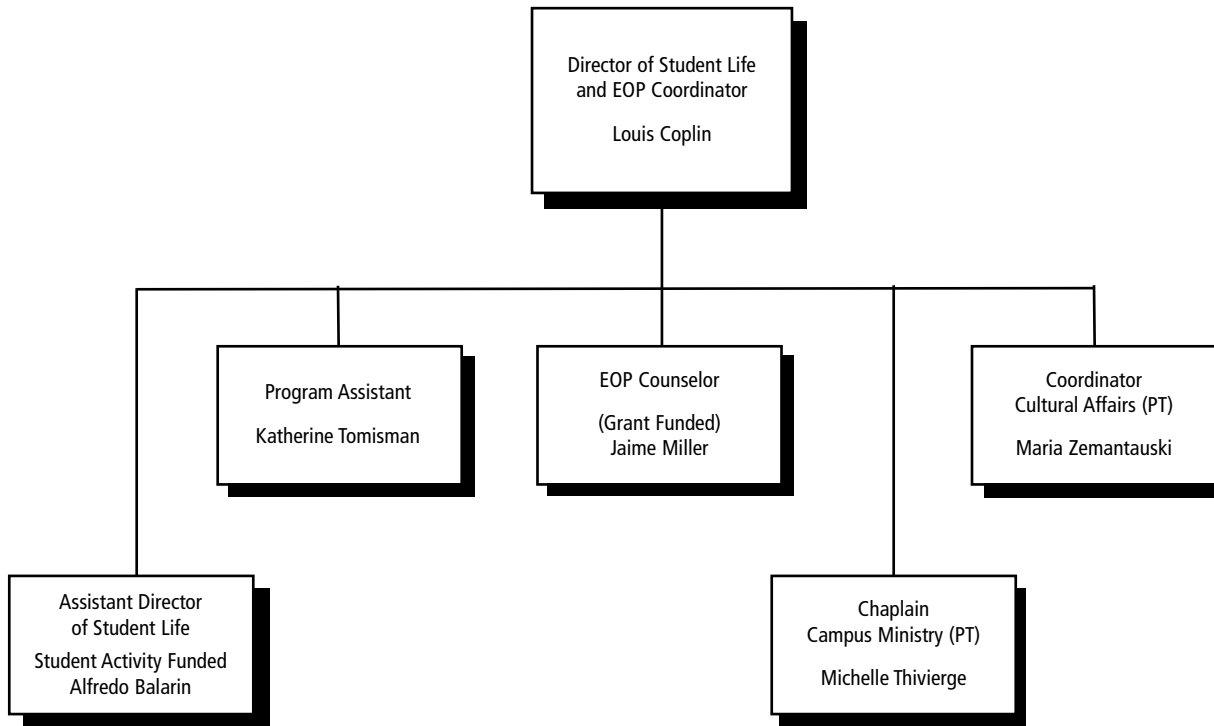

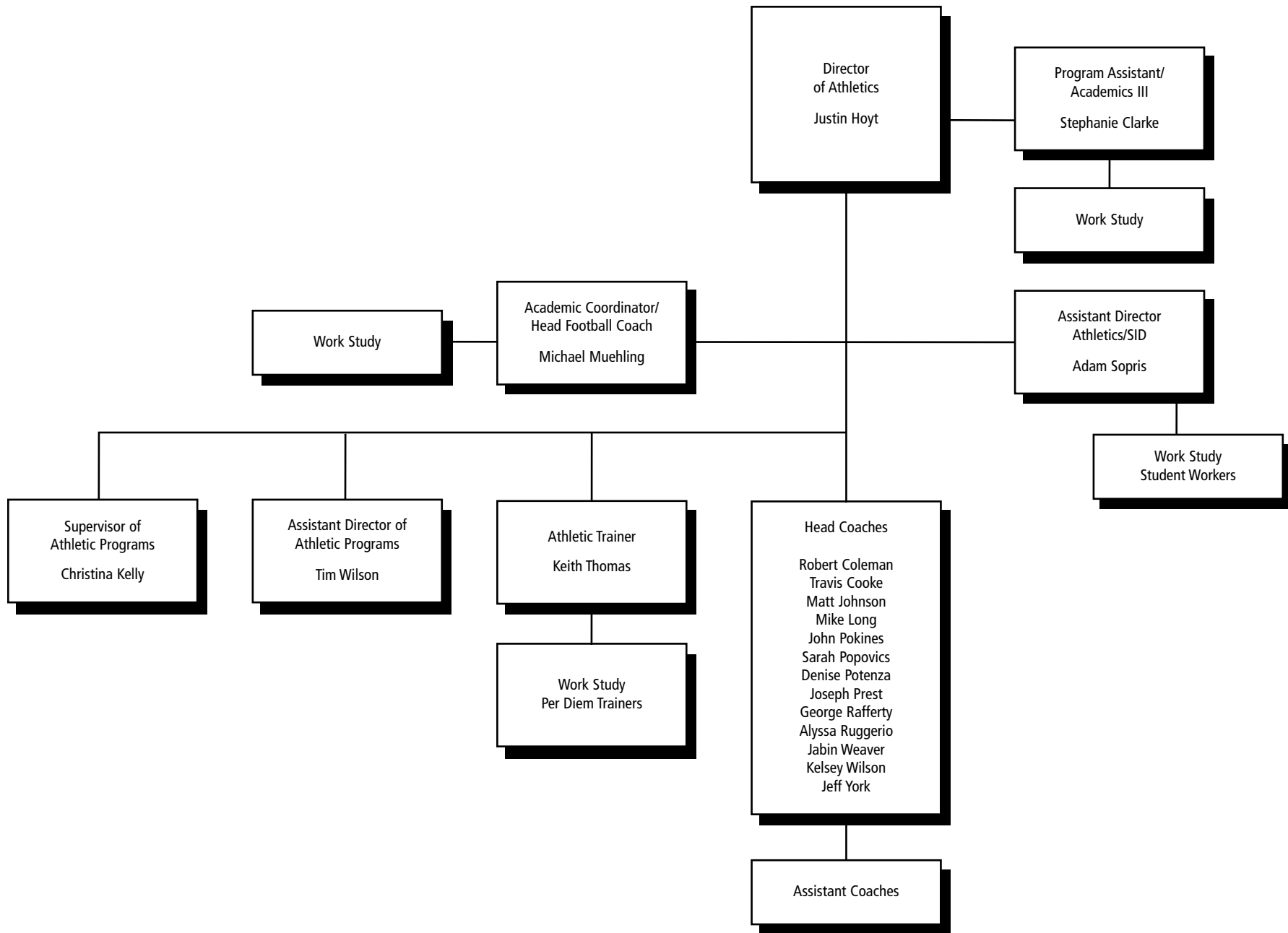

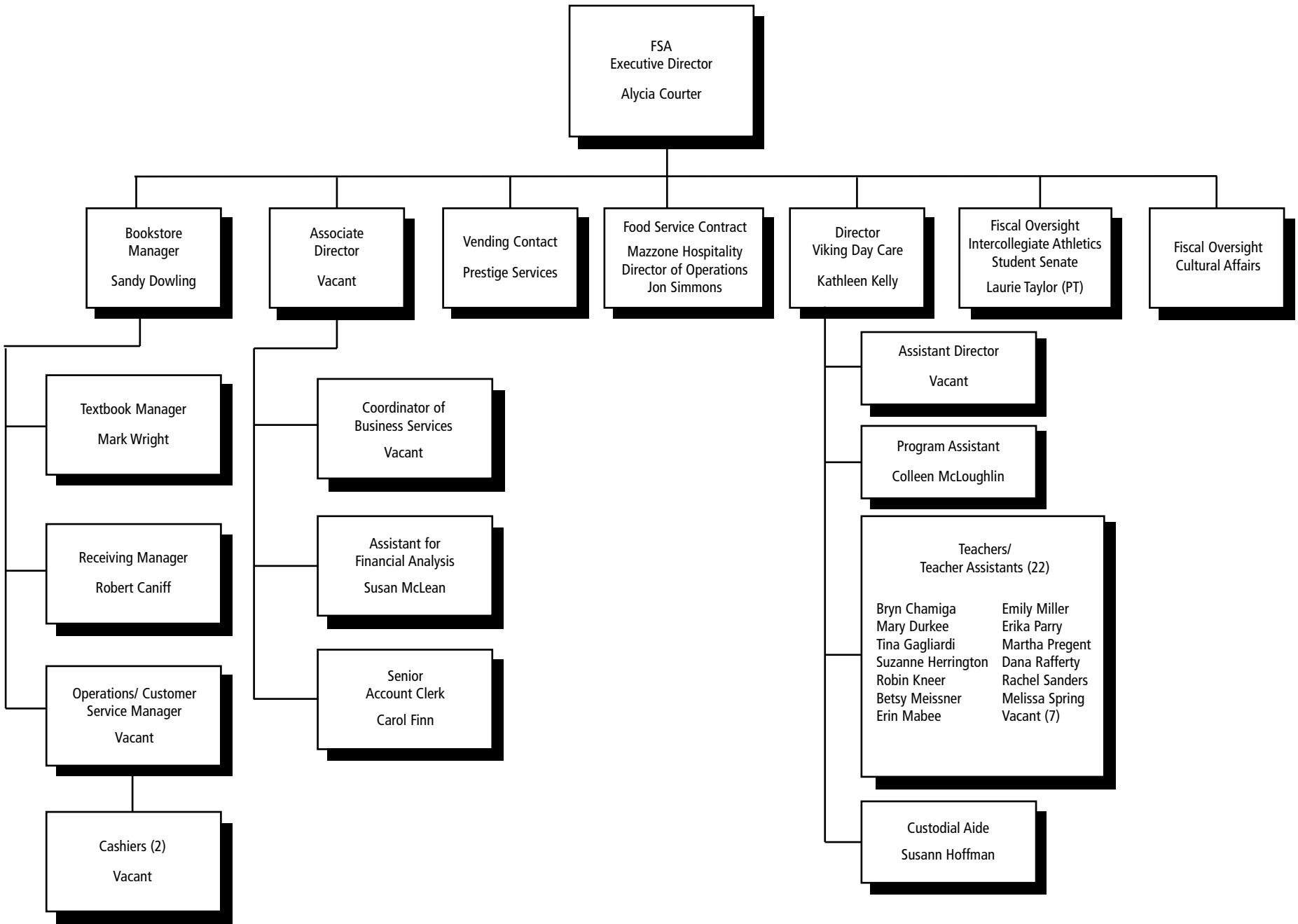

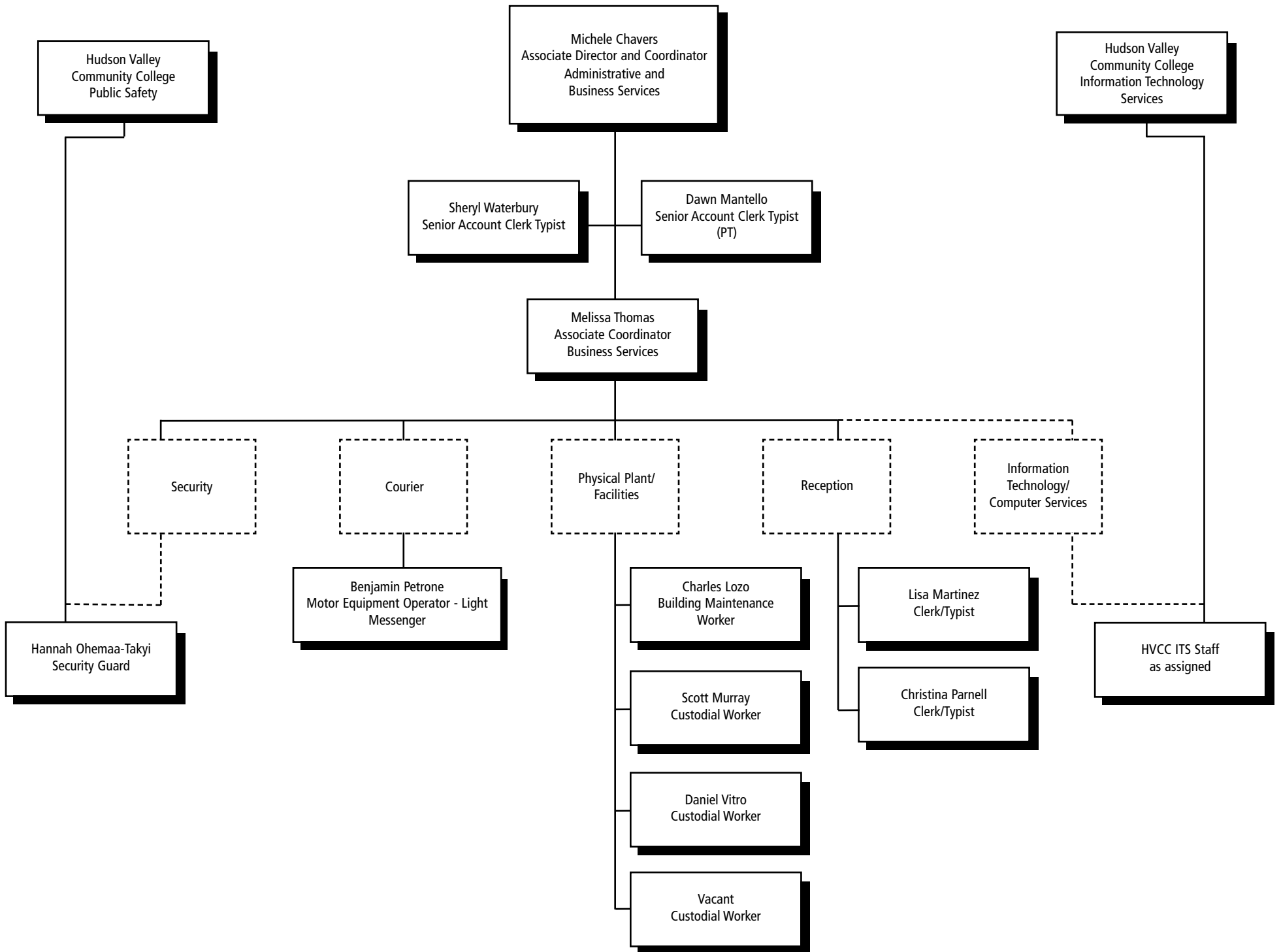

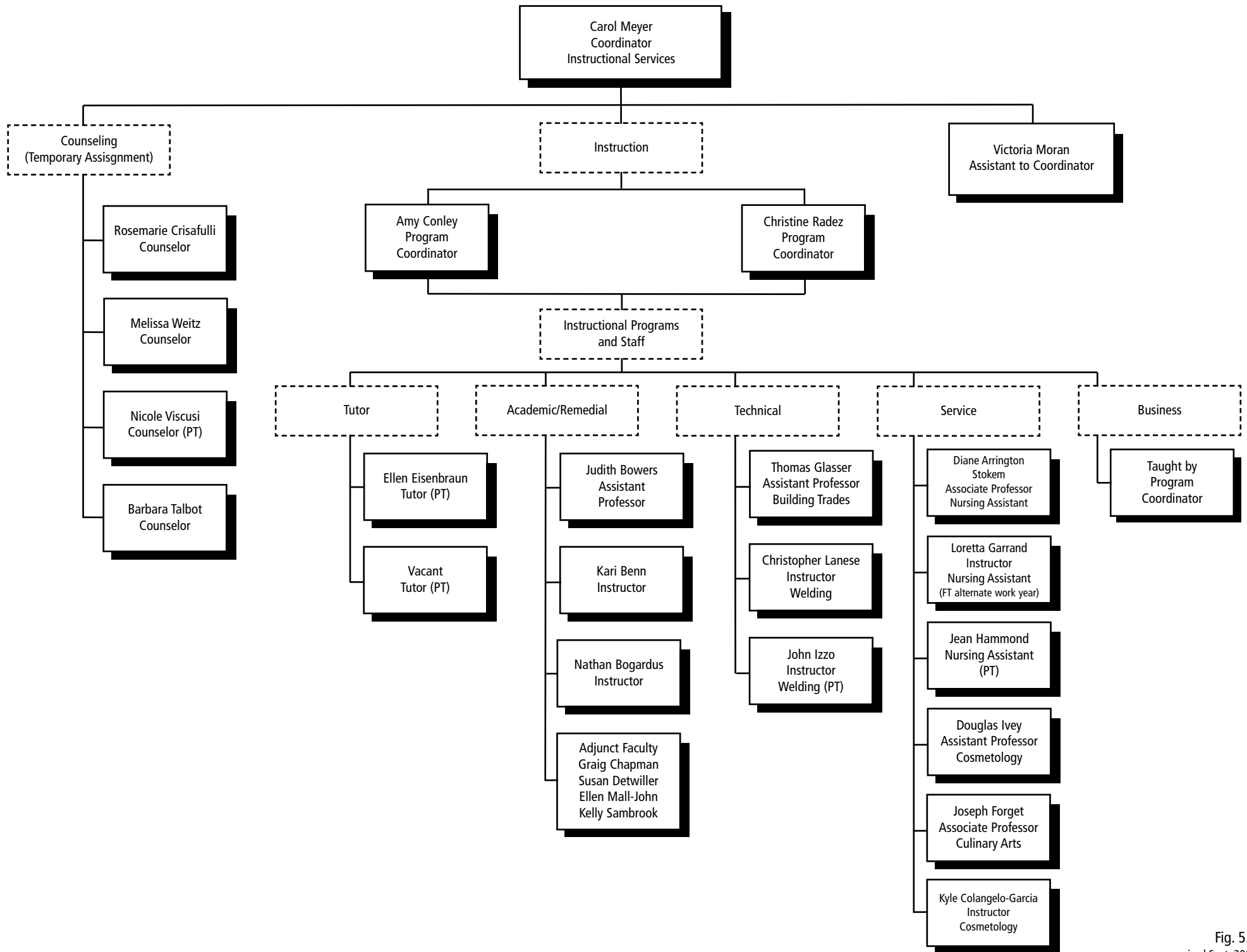

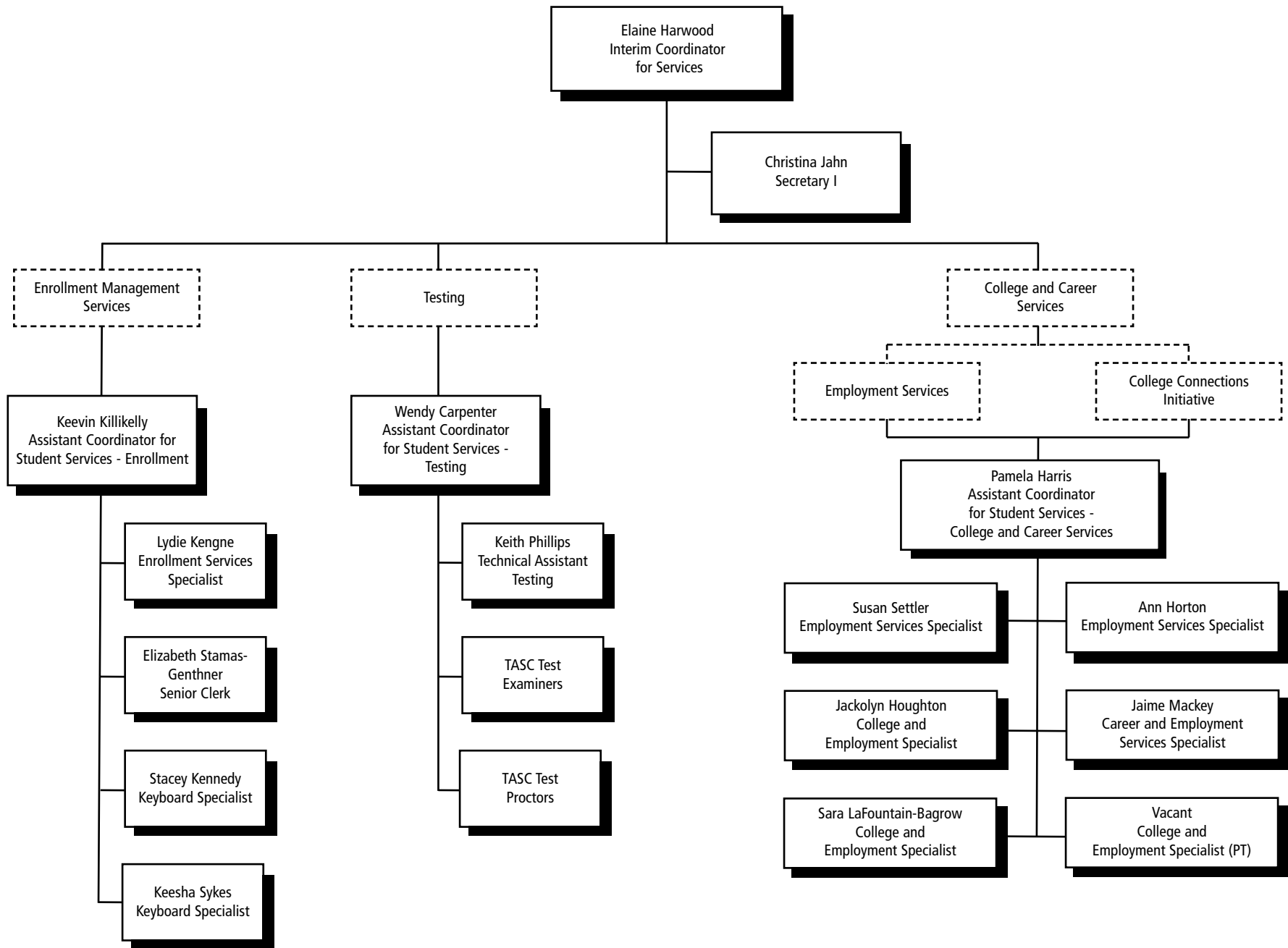

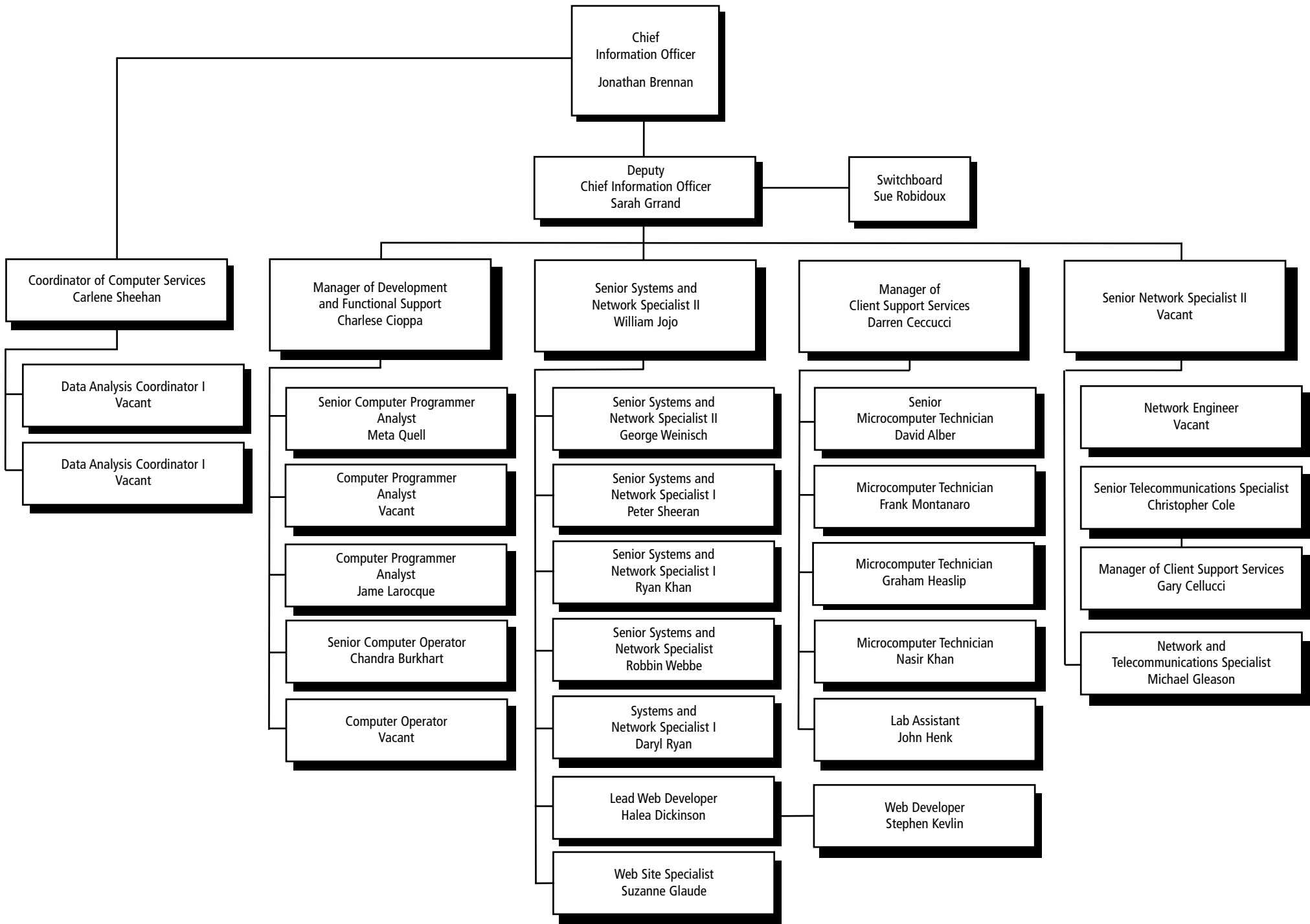

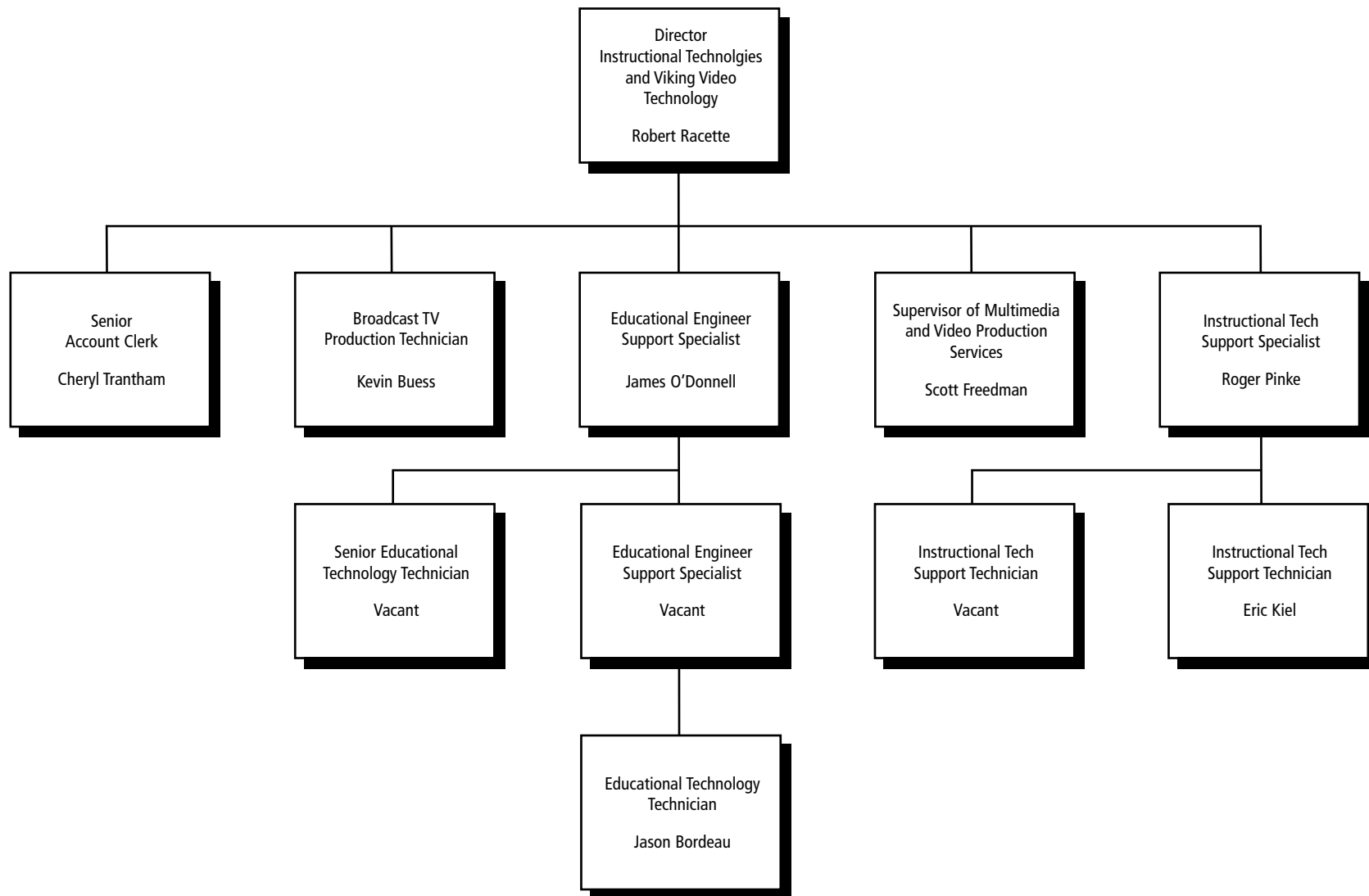
